

Purpose

This document provides you with key information about the investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products. This document sets out the generic risks of the PRIIP that you may be considering as a financial investment, in order that you can compare to other products. What is this product?

Type

OTC - forward

Objectives

FX Forwards are binding agreements to exchange an agreed amount in one currency (the notional amount) for a fixed amount in another currency at a fixed exchange rate (the forward rate) on an agreed settlement date.

On the settlement date, the investor has an obligation to exchange the notional amount at the forward rate.

The forward rate is determined by the spot exchange rate and the interest rate differential of the two currencies. Changes in these variables will impact the market value of the FX forward.

The terms set out below are illustrative of the terms of an FX Forward, but are not the exact terms you agree with SpareBank 1 Markets. The exact terms will be set out in each individual trade confirmation.

The illustrative terms are used for subsequent performance scenarios and calculation of costs.

In the agreement between you and SpareBank 1 Markets / SpareBank 1 SMN it is specified that if certain defined events occur, (1) SpareBank 1 Markets may adjust the product; and/or (2) SpareBank 1 Markets may terminate the product early. The return (if any) you receive on such early termination and/or adjustment is likely to be different from that received in the scenarios described above.

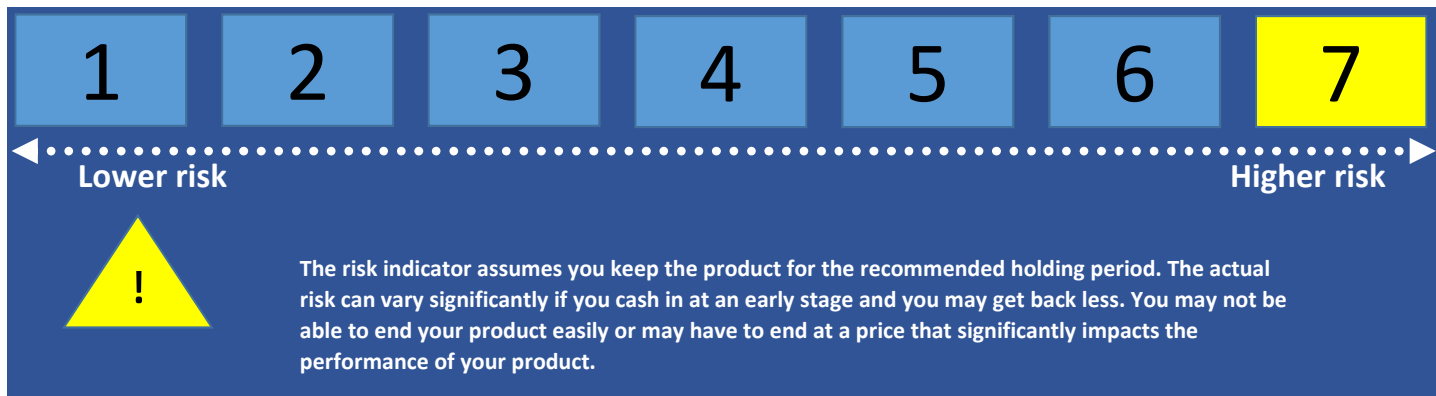
Intended retail investor

This product is intended for retail investors who

- (I) wish to hold an FX Forward for the agreed-upon term and do not want to sell it back prematurely and
- (II) are in the position to bear losses that may be unlimited

Term

The length of an FX Forward will depend on how long you wish to have the right to exchange the currency. The term will be agreed on before you enter into an FX Forward. An FX Forward is a bilateral agreement that cannot be ordinarily terminated unilaterally by either you or SpareBank 1 Markets.

What are the risks and what could I get in return?

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 7 out of 7, which is the highest risk class. **Please be aware of currency risk.** You will receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above. This product does not include any protection from future market performance so you could lose some or all of your investment. If we are not able to pay you what is owed, you could lose your entire investment.
